# GREATER BOCA RATON BEACH & PARK DISTRICT MINUTES OF THE FIRST PUBLIC HEARING ON PROPOSED 2018-2019 TAXES AND BUDGET

SUGAR SAND PARK - 300 SOUTH MILITARY TRAIL, BOCA RATON September 6, 2018

The MEETING was called to order by CHAIRMAN Robert K. Rollins, Jr. at 6:00 p.m.

#### PRESENTATION:

Proposed Millage Rate and Proposed 2018-2019 Budget

Mr. Arthur C. Koski, District Executive Director, stated that the District's 2018-2019 operating millage rate is **0.9147** mills. The budget is **13.1% more than** last year's total operating expenditures. He reviewed the line-items in the proposed budget. The total appropriated expenditures and reserves for Fiscal Year 2018-2019 are \$41,984,600.

### Board Discussion:

Commissioner Wright asked if golf course design and construction includes demolition costs. Mr. Koski responded that nothing has been set aside for the construction of the golf course facility. Demolition costs will probably be funded through Capital Reserve items.

Commissioner Wright inquired about the status of ending payments to the Boca Raton Community Redevelopment Agency (CRA). Mr. Koski stated that research is on-going to determine the District's options.

Commissioner Ehrnst suggested that the District pursue increased interest rate opportunities.

### PUBLIC COMMENTS AND QUESTIONS;

Mr. Robert DuKate noted that the National Golf Foundation study indicates golf course construction at almost \$10 million. He felt it was an omission by the Board not to include some funding in the budget for the golf course. Mr. Koski responded that it is not an omission, as the District never intended to pay the golf course construction with cash; it was intended to be paid for by debt. It will be a debt item and will be satisfied by District reserves.

Mr. Edward Carbone, Tournament Director for the former Allianz Championship, thanked the Board for its sponsorship of last year's Boca Raton Championship tournament. He asked the Board to consider some participation in the 2019 tournament. Chairman Rollins suggested keeping the budget as proposed, and revisit tournament participation at a later date.

Mr. Neil Haynie stated that he was delighted to hear about the possibility of a hotel at Boca National as it then becomes destination golf. He expressed disappointment that the District is not going to the rolled-back rate. He supports the initiation of the golf course with expansion over a

period of time. Referencing the 2018 Boca Raton Championship Tournament, the City and District made it clear that sponsorship was for the one time and representatives should acknowledge that understanding.

Chairman Rollins responded to Mr. Haynie by acknowledging that the last time the District did not go to the rolled-back rate was when it purchased the Swim & Racquet Center. Several City capital expenses that need to be done include the \$2.9 million pump & piping system at Gumbo Limbo as well as the boardwalk and tower. In the past, projects have been phased in, as the District has no other way to generate revenue except through ad valorem taxes and special interest activities.
