NOTE: While most synagogues have a Bar/Bat Mitzvah fee, our B'nai Mitzvah fee is now integrated into our tuition structure. This year, tuition has gone down for K-2nd and 7th-8<sup>th</sup>. Tuition is a bit higher for 4th-7th grade in order to catch up with the new system, but will go down next year. Additionally, Temple Beth El does not require payment into a building fund.
