ADVERTISEMENT FOR BIDS

Sealed Bids for Contract No. BC 152 – “Repair Snapped Pre-stressed Tendon in U-Channel over Indian Creek Bridge” must be received by the Town Clerk, Town of Bay Harbor Islands at 9665 Bay Harbor Terrace, Bay Harbor Islands, Florida 33154, up to **3:15 P.M. on December 13, 2018** at which time bids will be publicly opened and read aloud.

The nature and scope of this project is as follows:

Provide structural strengthening to the damaged pre-stressed U Channel that supports the sewer force main over the Indian Creek River. The U Channel may have been impacted by a vessel navigating under the bridge and caused the concrete cover to the pre-stressed tendons to be broken off; it is not clear whether the snapped pre-stressed tendons occurred at the time of impact or if the exposed tendons deteriorated over time to the point that they snapped.

The work includes furnishing all materials, labor, equipment, and services for the supply, installation and finish of all structural strengthening using an externally bonded FRP composite system.
