The nature and scope of this project are as follows:

Furnish all labor, materials, accessories, equipment, tools, transportation, services, technical competence, and supervision necessary to provide custodial services at the following facilities;

Town Hall; 1st floor administrative offices, 2nd-floor building department offices, staff kitchen/breakroom, Town Council Chambers, 1st and 2nd-floor interior restrooms, outside access public restrooms, 1st and 2nd-floor outdoor elevator lobbies and stairway, elevator cab interiors and outside elevator cladding on each level; Annex (inclusive of; public works administrative offices, human resources office, accounting office, finance director's office, IT offices, field staff kitchen/break room, restroom, locker room, showers and shower area). **Services to occur Monday through Friday of each week, excluding Town-recognized holidays.**
