#### Call to Order:

- **b.** Approval of: November 16, 2016 Council Meeting Minutes.

#### 4. New Business

a. Approved on First Reading Ordinance No. 116; An Ordinance of the Village of Golf, Florida, establishing requirements for the Village of Golf's Property Assessed Clean Energy Program ("PACE"); providing for Multi-Jurisdictional PACE Programs in order to allow for third-party administrators, either for-profit or not-for-profit, to administer the PACE Program within the Village pursuant to State Law and the requirements set by the Village; providing a conflicts clause and a severability clause; providing an effective date; and for other purposes. Attorney Biggs read the Ordiinance by title only.

Motion was made by Council Member Buchanan, seconded by Council Member Windle and Voice Vote Showed: unanimously carried to approve on first reading, Ordinance No. 116. Second Reading of the AYES - 5 Ordinance will be at the January 18th Council Meeting.

#### b. Penny Sales Tax Discussion;

Palm Beach County voters approved the 1-cent sales tax for a period of 10 years. Although the Village did not sign the interlocal agreement, we are still bound by the provisions. The referendum requires a citizen oversight committee. Council asked Attorney Biggs to do research as to whether Council can sit as the oversight committee. Council

d. Lift Station Monitoring - Request for a Capital Expenditure:

unanimously carried to approve the updates to the Employee Handbook.

Manager Thrower asked Utilities Superintendent Lisle to explain SCADA and the cellular service now available for monitoring of all of the lift stations. The cost to purchase and install the system would be no more than \$30,000. Motion was made by Council Member Buchanan, seconded by Council Member Botos and Voice Vote Showed:

unanimously carried to approve the request for the purchase and installation of a cellular **AYES** - 5 monitoring system.
